- Nomination papers may be obtained from the offices of the Returning Officer, Council Offices, Codsall, South Staffordshire, WV8 1PX, during the times stated above.
- If any election is contested the poll will take place on Thursday 2<sup>nd</sup> May 2019.
- Applications to register to vote must reach the Electoral Registration Officer by 12 midnight on Friday 12<sup>th</sup> April 2019. Applications can be made online: <https://www.gov.uk/register-to-vote>.
- Applications, amendments or cancellations of postal votes must reach the Electoral Registration Officer at Council Offices, Codsall, South Staffordshire, WV8 1PX by 5pm on Monday 15<sup>th</sup> April 2019.
- Applications to vote by proxy at this election must reach the Electoral Registration Officer at Council Offices, Codsall, South Staffordshire, WV8 1PX by 5 pm on Wednesday 24<sup>th</sup> April 2019.
- Applications to vote by emergency proxy at this election on grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at Council Offices, Codsall, South Staffordshire, WV8 1PX by 5 pm on Thursday 2<sup>nd</sup> May 2019. The physical incapacity must have occurred after 5 pm on Wednesday 24<sup>th</sup> April 2019. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after 5 pm on Wednesday 24<sup>th</sup> April 2019.
